### OUR DRINKING WATER MEETS OR EXCEEDS ALL FEDERAL (EPA) DRINKING WATER REQUIREMENTS

This report is a summary of the quality of the water we provide our customers. The analysis was made by using the data from the most recent U.S. Environmental Protection Agency (EPA) required tests and is presented in the attached pages. We hope this information helps you become more knowledgeable about what's in your drinking water.

#### **Special Notice for the ELDERLY, INFANTS, CANCER PATIENTS, people with HIV/AIDS or other immune problems:**

#### **WHERE DO WE GET OUR DRINKING WATER?**

The **RRA-Lockett Water System** purchases ground water from the City of Vernon. The Texas Commission on Environmental Quality (TCEQ) has completed and provided the Authority a Source Water Susceptibility Assessment for the drinking water source(s) that we own as well as for the system(s) from which we purchase water. This report describes the susceptibility and types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. ## **SYSTEM INFORMATION**

The Red River Authority of Texas owns and operates 30 registered public water supply systems through its Utility Division. The Utility Division maintains over 2,200 miles of transmission lines, two surface water treatment plants, 42 pumping facilities, and serves approximately 10,000 customers residing in a 15 county area of the Red River Basin. The Utility Division is subdivided into geographical districts for proper management, maintenance, and financial accounting of individual systems.

The **RRA-Lockett Water System** is one of the water systems operated by the Utility Division's District 13. In 2014, the system served 279 active connections with an average water use of 189 gallons per day per connection. In the water loss audit submitted to the Texas Water Development Board for the time period of January - December 2014, the system lost an estimated 8.4 MG of water. The primary use of the water was rural domestic. No major capital improvements items were scheduled for 2014.

## **DEFINITIONS:**

### **Maximum Contaminant Level (MCL) -**

The highest level of a contaminant in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

### **Maximum Contaminant Level Goal (MCLG) -**

The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

**Organic Contaminants** - TESTING WAIVED, NOT REPORTED, OR NONE DETECTED

**Fecal Coliform** - REPORTED MONTHLY TESTS FOUND NO FECAL COLIFORM BACTERIA.

**Total Coliform** - REPORTED MONTHLY TESTS FOUND NO COLIFORM BACTERIA.

**Unregulated Initial Distribution System Evaluation for Disinfection Byproducts** - WAIVED OR NOT YET SAMPLED

### **Maximum Residual Disinfectant Level (MRDL) -**

The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

### **Maximum Residual Disinfectant Level Goal (MRDLG) -**

The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

### **Treatment Technique (TT) -**

A required process intended to reduce the level of a contaminant in drinking water.

### **Action Level (AL) -**

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**NTU** - Nephelometric Turbidity Units

**MFL** - million fibers per liter

**pCi/L** - picocuries per liter (a measure of radioactivity)

**ppm** - parts per million, or milligrams per liter (mg/l)

**ppb** - parts per billion, or micrograms per liter (ug/l)

**ppt** - parts per trillion, or nanograms per liter

**MG** - million gallons

## **SECONDARY CONSTITUENTS**

Many constituents (such as calcium, sodium, or iron) which are often found in drinking water, can cause taste, color, and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not the EPA. These constituents are not causes for health concerns. Therefore, secondary constituents are not required to be reported in this document, but they may greatly affect the appearance and taste of your water.

## **Additional Health Information for Lead**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. This water supply is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
